

# Active April - Smart Steps for Schools 2014

## TERMS & CONDITIONS

1. The competition entry instructions form part of these terms and conditions.
2. The competition commences at 12.01am AEST on 10/3/2014 and entry closes at 5.00pm AEST on 30/4/2014 (the “competition period”).
3. Entry into this competition is open to all persons residing in Victoria aged 18 or over who submit an entry during the competition period (“Eligible Entrants”). Entries submitted by persons aged 18 and under will be deemed eligible provided that the entrant’s parent or guardian accepts responsibility for the entrant’s submission.
4. The Promoter is Victoria Walks Inc (No. A0052693U) ABN: 88419420305 of Level 7, 225 Bourke Street, Melbourne VIC 3000.
5. Eligible Entrants will be limited to one entry into each part of the competition. For Eligible Employees of the Promoter and their suppliers, or their immediate families are not eligible to enter the competition.
6. By submitting photos, artwork, maps or other information (the submission), the Eligible Entrant is representing to Victoria Walks that:
  - a. The submission is the Eligible Entrant's own work;
  - b. The Eligible Entrant indemnifies and holds harmless Victoria Walks in the event that the submission or any part thereof is not the Eligible Entrant's own work and/or otherwise constitutes a breach of copyright; and
  - c. The Eligible Entrant has obtained the relevant consent required by law from any subjects that are featured in the submission for the purpose of their image to be used as set out in clause 15, without payment of fee or other consideration by Victoria Walks.
7. Photos, artwork, maps and information submitted to the competition must be taken in Victoria. Photos, artwork, maps and information created outside of Victoria do not constitute a valid entry to the competition.
8. Victoria Walks reserves the right to disqualify unsuitable entries.
9. Winners will be judged according to the photos, artwork, maps and information most likely to inspire more students and school communities to walk every day, as decided by Victoria Walks.

However, Victoria Walks may, in agreement with the winning school, award vouchers sourced from a business or organisation other than Sportime Australia.

13. Other than as stated in clause 12, the prizes must be taken as stated. No compensation will be payable if the winners are unable to use the prize as stated for whatever reason. If the prize is not taken for any reason it is forfeited.

14. The winning school will be notified by email or phone on 2 May 2014.

Victoria Walks may edit, use part of or quote from the story, photos or artwork in any publications or publicity materials as it sees fit.

16. The Eligible Entrant agrees that no fee or other consideration will be payable by Victoria Walks for its right to use the Eligible Entrant's submission, whether in respect of a license fee or otherwise, other than the entry of the Eligible Entrant into the competition.
