TERMS and CONDITIONS

- 1. The competition entry instructions form part of these terms and conditions.
- 2. The competition commences at 12.01am AEST on Wednesday April 11th 2018 and entries close at 11.59pm AEST on Wednesday April 25th 2018 (the "competition period").
- 3. Entry into this competition is open to all persons residing in Victoria aged 18 or over who submit an entry during the competition period ("Eligible Entrants").
- 4. The Promoter is Victoria Walks Inc (No. A0052693U) ABN: 88419420305 of Level 7, 225 Bourke Street, Melbourne VIC 3000.
- 5. Eligible Entrants will be limited to **three photo entries** into the competition. Employees of the Promoter and their suppliers, or their immediate families are not eligible to enter the competition.
- 6. By submitting photos (the **submission**), the Eligible Entrant is representing to Victoria Walks that:
 - a. The submission is the Eligible Entrant's own work;
 - b. The photo is taken within Victoria;
